Dexion Commerical Warranty

In addition to the minimum conditions or warranties expressed or implied by the *Competition and Consumer Act 2010* or other similar legislation relating to the sale of products of this kind in Australia, **Dexion Group**, as defined below ['Dexion'], provides the following commitment to the Customer in support of any 'Dexion Commercial' branded product or part supplied and installed by Dexion, ['Dexion Commercial product or part'].

1. WARRANTY AGAINST STRUCTURAL FAILURE

- 1.1. Dexion warrants to the Customer that if a Dexion Commercial product or part structurally fails within the Designated Time Period, then that Dexion Commercial product or part will be repaired or replaced with a new or equivalent product or part free of charge, subject always to application, stress or imposed loadings in excess of that specified by Dexion or misuse, negligence or accident, as Dexion determines, by parties other than Dexion.
- 1.2. This warranty will be void where the Dexion Commercial product or part has been subjected to application, stress or imposed loadings in excess of that specified by Dexion or misuse, negligence or accident, as Dexion determines, by parties other than Dexion.
- 1.3. The Customer must immediately give written notice to Dexion and/or its authorised representative upon discovery of a suspected defect in the Dexion Commercial product or part and allow Dexion access to the place of installation for the purpose of inspecting the Dexion Commercial product or part and fulfilling its obligations under this warranty.
- 1.4. This warranty is not transferable and only applies to the Customer and any new and previously unused Dexion Commercial product or part. It does not otherwise apply and is subject to the exclusions set out in clause 7.

2. WARRANTY AGAINST DEFECTS IN MATERIALS AND WORKMANSHIP

- 2.1 Dexion warrants to the Customer that for a period of 10 years from the Date of Delivery, ("Warranty Period"), Dexion Commercial products or parts will under normal and proper use be free from defects in materials and workmanship and that any Dexion Commercial product or part that, in Dexion's reasonable opinion, has deteriorated due to defects in materials and/or workmanship by Dexion will be replaced or repaired by Dexion without cost to the Customer in accordance with the terms and conditions of this warranty.
- 2.2 For this warranty to remain valid:
 - a) The Customer must allow Dexion to inspect the installation of the Dexion Commercial product when requested; and
 - b) Any Dexion Commercial product or part that, in Dexion's opinion, is damaged or has deteriorated due to normal wear and tear or local environmental conditions must be promptly replaced at the Customer's cost. Failure by the Customer to replace any Dexion Commercial product or part identified by Dexion as having deteriorated in this way will void the Lifetime Warranty.
- 2.3 Unless otherwise notified in writing, Dexion and/or its representative's inspection will be charged to the Customer at the rate applicable at the time of inspection, as notified in writing from time to time by Dexion and/or its authorised representative. The Customer must pay Dexion any such fees or charges promptly and in accordance with Dexion's payment terms, failing which this Lifetime warranty will be deemed void and of no effect.
- 2.4 This warranty is not transferrable and only applies to the Customer and any new and previously unused Dexion Commercial product or part that has been installed by Dexion and/or its authorised representatives. It does not otherwise apply and is subject to the exclusions in clause 7.

3. PRODUCTS REQUIRING REGULAR MAINTENANCE

The warranty on Dexion mechanised equipment with moving parts is conditional upon regular preventative maintenance performed by Dexion service engineers as Dexion reasonably notifies the Customer is necessary, and is subject to the exclusions in clause 5.

4. MANUFACTURER'S WARRANTY

Dexion shall endeavour to assign and give to the Customer the benefit of any guarantee or warranty received by Dexion from the supplier or manufacturer.

5. CONDITIONS OF THIS WARRANTY

The application of the Dexion Commercial Warranty is conditional upon the following:

- 5.1 The installation must be inspected within a reasonable period of time of Dexion's request to inspect;
- 5.2 Immediate notification to Dexion of damage, or potential damage, to the installation and any part thereof, caused by either the collision of moving objects or from earthquakes or other natural disasters.

Dexion Commercial Warranty

- 5.3 At the time of notification of the warranty claim, the Customer must provide to Dexion the date of delivery and any serial number relating to the relevant product, together with such information as Dexion may reasonably require concerning the alleged defect.
- 5.4 Where recommended by Dexion, immediate compliance with instructions to repair the installation or replace some of its parts, and/or to unload the installation or suspend use of installation; and
- 5.5 Use and loading of the installation as intended, within rated capacities and loads, as advised by Dexion.

6. RETURNS

The Customer must not return any Goods to Dexion unless specifically requested to do so by Dexion.

7. EXCLUSIONS

- 7.1 This warranty will only apply to a new Dexion Commercial product or part manufactured by Dexion and will not otherwise apply. Dexion will endeavour, but makes no representation or warranty that it will be able, to assign to the Customer the benefit of any warranty from the supplier or manufacturer of auxiliary products or parts supplied by Dexion and for the removal of doubt, this Lifetime warranty does not extend to, include or cover any such auxiliary products or parts supplied or manufactured by a third party. Any modification, repair or alteration of the Dexion Commercial product or part by any third party without Dexion's prior written approval voids Dexion's obligations under this warranty.
- 7.2 If any Dexion Commercial product or part is to be removed from an installation, moved to another location and is intended for active service at the new location, the Dexion Commercial product or part must be re-certified by Dexion (which certification may be withheld in Dexion's absolute discretion) in order to maintain this warranty.
- 7.3 This warranty does not apply if:
 - a) the products have been used to perform functions other than the functions for which they were designed;
 - b) the products have not been used in accordance with any relevant Dexion product user manuals, which have been provided to the Customer or may be provided to the Customer upon request;
 - c) the products have been repaired or altered by any third party without Dexion's prior written approval;
 - d) the products have been damaged by an external source regardless of its nature, including without limitation damage caused by ultraviolet light or exposure to extreme environmental conditions such as salt or chlorinated air;
 - e) the products have not been manufactured by Dexion;
 - f) the products are subjected to use or conditions, which are either abnormal or in excess of any capacity or purpose recommended by Dexion;
 - g) in the reasonable opinion of Dexion, the alleged defect is not attributable to faulty materials or workmanship; or
 - h) the Customer fails to notify Dexion of the claim within the Warranty Period..

8. LIMITATION OF LIABILITY

8.1 Dexion's liability under this warranty will be limited to one of the following at the election of Dexion:

- 1.1. Repair of the Dexion Commercial product or part; or
- 1.2. Delivery and installation of a replacement product or part identical or equivalent to the original product or part.

8.2 Notwithstanding any other provision of this Warranty, to the extent permitted by law, Dexion will not be liable to the Customer or any other party for any loss of profit, loss of income, loss of sales, loss of market, loss of use, loss of rent, loss of goodwill or reputation, loss of opportunity, third party claims, incidental or special damages or indirect or consequential loss of any kind howsoever arising.

9. OTHER

- 9.1 Dexion reserves the right to make improvements to any product or part as to design, materials or otherwise without incurring any obligations to install or make such improvements to any Dexion Commercial product or part already supplied.
- 9.2 Any dispute regarding the terms or conditions of this warranty shall be resolved by Dexion, the outcome of any such dispute to be as determined by Dexion in its absolute discretion.
- 9.3 This warranty is governed by the laws of New South Wales.

10. DEFINITIONS

In this warranty:

'Customer' means the party that purchased the Dexion Commercial product or part from Dexion.

Dexion Commerical Warranty

'Date of Delivery' means the original date upon which the products or parts were delivered to the Customer. The Date of Delivery does not include any subsequent delivery dates of replacement products or parts.

'Designated Time Period' means the number of years from the date of delivery of the Dexion commercial products or parts as specified in the Schedules below.

'Dexion Group' means Dexion (Australia) Pty Limited and its related companies, including Dexion Commercial (Australia), Dexion Sdn Bhd and GUD NZ Holdings Limited t/as Dexion Commercial.

'Installation': the collective structure which has been assembled by Dexion, comprising the Parts and Products.

'Part': a product component, supplied by Dexion.

'Product': a Dexion Commercial product.

'Structural failure or any other defect' means cracking, breaking or collapsing of the Dexion Commercial product or part not resulting from misuse, negligence, fraud or accident.

'Workmanship': the quality and skill utilised in manufacturing the Parts and Products.

During the 10-year warranty period, all parts are included at no cost for 10 years. Labor is included at no cost during the first year of the 10-year warranty period. After the first year, all labor will be charged at the current rate.

5-YEAR LIMITED WARRANTY
